

 while also defending its reputation and products.
- Actively lead, direct and co-ordinate the activities of the Fluoropolymers Product Group, in alignment with Plastics Europe' overall objectives and strategy.

Membership and group management

- Lead the Fluoropolymers Group's secretariat, i.e. implementation of the strategy, budgeting and financial reporting, people management for the Administrative Assistant, management of service providers and negotiation of related contracts
- Ensure effective functioning of the Product Group activities and sub-groups as per the Plastics Europe statuses and Product Group Internal Rules, including all applicable internal processes/policies and relevant sub-delegations, as the case may be
- Constructively contribute as Product Group Director to Plastics Europe's Leadership Team

- Excellent networker with excellent social and cross-cultural and diplomatic skills
